PRODUCT DESCRIPTION

A premium quality emulsion based, Textured, exterior wall coating with good flexibility and hairline crack bridging ability.

INTENDED USES:

- 1. To weatherproof and to protect exterior wall surfaces.
- 2. To obliterate hairline cracks on exterior cement plasters.
- 3. For application to correctly prepared and primed cement plaster, unglazed bricks, breeze blocks and fibre cement.

FEATURES:

- 1. UV resistant resists severe sunlight conditions normal fading of colours can take place over time.
- 2. Excellent flexibility to keep hairline cracks obliterated, when applied at less than 5m² per litre.
- 3. Water-based easy to apply and clean up.
- 4. When applied as recommended the achieved dried film thickness is double as much of conventional paints.
- 5. Tough and durable for long term protection of exterior walls.
- 6. Good water resistance to prevent penetration of dampness on exterior walls.
- 7. Can be tinted to specific colour requirements.

APPLICATION DETAILS:

Mixing: Stir well before use with a flat paddle to an even consistency. Stir occasionally during

use.

Method: Roller (long woven pile or high loading long pile) and brush.

Thinning: Not recommended.

Cleaning: Remove as much of the product as possible from the application equipment before

cleaning with water.

or 3°C above dew point, if possible away from direct sunlight

Note: higher temperatures will accelerate the drying times (approximately halved for every 10°C increase) whilst lower temperatures will retard the drying times

(approximately doubled for every 10°C decrease).

Requirements: 2 coats minimum. Some bright and chromatic colours may require additional coats.

SURFACE PREPARATION

Surfaces must be sound, clean and dry (moisture content below 15%) before painting. Newly applied plaster need to be left for 21 to 28 days or 1 week for every 5mm thickness of plaster. Undesirable weather conditions e.g. cold or wet weather conditions will results in extended curing period.

Plaster sand to comply with SABS 1090 requirements. Plaster mix must have a minimum thickness of 10mm, free from soft and friable material and comply with SABS 0164-1 for strength (MPA).

New Work:

Primer.

2. Wood One coat Prominent Wood Primer.

3. Unglazed bricks, breeze blocks One coat Prominent Damp Cure or Prominent Select Plaster

Primer.

Redecorating:

1. Gloss enamel Sand well, clean and apply Prominent Select Universal Undercoat.

2. Sound matt emulsion paint Clean down with Prominent General Purpose Cleaner and water

solution (1:10), allow drying. If sound apply direct.

3. Sound gloss or sheen painted surfaces Sand down to a matt finish and then wash with Prominent General

Purpose Cleaner diluted (1:10) with water. Allow drying and apply

direct.

4. Chalky surfaces Wire brush/high-pressure water wash at 200 bar and a rotating

nozzle and allow curing. Apply one coat Prominent Damp Cure or

Prominent Surface Restorer.

5. Painted in poor condition Remove to sound surface and treat as new work.

LIMITATIONS:

- 1. Can only be applied under specified climatic conditions.
- 2. Spreading rate of 5m²/litre cannot be exceeded.
- 3. Spot touch-up will lead to texture or colour variations, to ensure a consistent appearance ensure that the batch number on all the containers used are the same, where batch numbers on the container differ, intermix before use.
- 4. Cannot be applied to bare, un-primed metal.
- 5. Cannot be over coated with non-flexible paints.
- 6. By implementing consistent application techniques to the newly applied paint and to lay the application from the top to bottom will improve the overall aesthetic appearance.
- 7. When tinting dark colours from a clear tint base, note that the recommended DFT could be lower due to the volume solid content. For this reason additional coats may be required to achieve good opacity and an aesthetically pleasing finish.

SAFETY PRECAUTIONS:

- 1. Keep out of reach of children.
- 2. Ensure to maintain good ventilation during application and drying process.
- 3. Wear a suitable dust mask if sanding.
- 4. In case of skin contact, wash with soap and water or a recognised skin cleaner. Avoid contact with eyes. In case of contact with eyes rinse immediately with running water and seek medical advice.
- 5. If product is ingested drink plenty of water. Do not induce vomiting at any time. Seek medical advice.
- 6. Do not smoke while painting.
- 7. Refer to the Material Safety Data Sheet (MSDS) for detailed information about the product and transportation and classification criteria. MSDS is available on www.prominentpaints.co.za or from Prominent Customer Service Department.
- 8. To avoid any risk of spillage, always transport in a secure upright position.
- 9. If the surface to be painted is asbestos then the preparation, cleaning and/or removal of broken asbestos sheeting needs to be done in compliance to the Asbestos Regulations, 2001 of the Occupational Health and Safety Act 1993. TINT BASE:

Characteristics:

- 1. The tint base containers are only filled to levels which are specific for each tint base to allow the calculated volume of colourant to be added in order to achieve the volume indicated on the container after tinting.
- 2. Tint bases and colourants are unfinished products which should not be used on their own.
- 3. Only once the prescribed colourant is added to the specific tint base will the finished product comply with the technical features and related information as set out in this TDS.
