SURFACE PREPARATION

Surfaces must be sound, clean and dry (moisture content below 15%) before painting. Newly applied plaster need to be left for 21 to 28 days or 1 week for every 5mm thickness of plaster. Undesirable weather conditions e.g. cold or wet weather conditions will results in extended curing period.

Plaster sand to comply with SABS 1090 requirements. Plaster mix must have a minimum thickness of 10mm, free from soft and friable material and comply with SABS 0164-1 for strength (MPA).

New Work:

1.	Cement plaster sound with 15% or less moisture.	One coat Prominent Select Wall and Ceiling or Prominent Select Plaster Primer.				
2.	Cement plaster sound with 40% or less moisture.	One coat Prominent Damp Cure. Only proceed once the moisture contents prove to be 15% or less.				
3.	Unglazed bricks, breeze blocks and fibre cement	Apply Prominent Damp Cure or Prominent Select Plaster Primer				
4.	Gypsum plaster.	Apply Prominent Select Plaster Primer.				
Redecorating:						
1.	Chalky surfaces.	Wire brush/high-pressure water clean the surface and apply one coat Prominent Damp Cure or Prominent Surface Restorer.				
2.	Sound matt emulsion painted surfaces.	Clean down with Prominent General Purpose Cleaner and water mixture (1:10), allow drying. If sound, apply direct.				
3.	Sound gloss or sheen painted surfaces.	Sand down to a matt finish and then wash with Prominent General Purpose Cleaner diluted (1:10) with water. Allow drying and apply direct.				
4.	Painted surface in poor condition i.e. excessive peeling.	Remove to sound surface and treat as new work.

LIMITATIONS:

- 1. Spot touch-ups will lead to colour/texture variations.
- 2. Can only be applied under specified climatic conditions.
- 3. Spreading rate of 5m²/litre cannot be exceeded.
- 4. Textured is not a controlled tinting base and therefore only eye tinting can be done for light pastel colours using universal paint stainers.
- 5. To ensure a consistent appearance ensure that batch numbers on all the containers are the same, where batch numbers differ, intermix before use.
- 6. By implementing consistent application techniques to the newly applied paint and to lay the application from the top to bottom will improve the overall aesthetic appearance.
- 7. When tinting dark colours from a clear tint base, note that the recommended DFT could be lower due to the volume solid content. For this reason additional coats may be required to achieve good opacity and an aesthetically pleasing finish.

SAFETY PRECAUTIONS:

- 1. Keep out of reach of children.
- 2. Ensure to maintain good ventilation during application and drying process.
- 3. Wear a suitable dust mask if sanding.
- 4. In case of skin contact, wash with soap and water or a recognised skin cleaner. Avoid contact with eyes. In case of contact with eyes rinse immediately with running water and seek medical advice.
- 5. If product is ingested drink plenty of water. Do not induce vomiting at any time. Seek medical advice.
- 6. Do not smoke while painting.
- 7. Refer to the Material Safety Data Sheet (MSDS) for detailed information about the product and transportation and classification criteria. MSDS is available on www.prominentpaints.co.za or from Prominent Customer Service Department.
- 8. To avoid any risk of spillage, always transport in a secure upright position.
- 9. If the surface to be painted is asbestos then the preparation, cleaning and/or removal of broken asbestos sheeting needs to be done in compliance to the Asbestos Regulations, 2001 of the Occupational Health and Safety Act 1993.
